As we close fiscal year 2025, I am honored to reflect on the incredible generosity of our donors and the enduring impact of philanthropy on our university.

In FY25, the Foundation raised a record amount of \$3.6 million and supported a variety of projects including the establishment of the Gary E. West Aviation Center and Endowed Scholarship, the replacement of the Blatnik Gymnasium floor, improvements to the Campus Woods Trails, lighting upgrades for the Emmett R. Boyle Conference Room, essential equipment for the Dental Hygiene program and Biology Lab and the establishment of 12 new named scholarships

In addition, your contributions to the WLUF Annual Fund have continued to provide critical scholarship support for students which eases their financial burden and helps sustain the University. The robust Hilltopper Athletic Club Fund enhances the experience of student athletes and fans alike. ## PRESIDENT'S RECOGNITION BANQUET 2025 HONORS DONORS

On October 24, West Liberty University (WLU) proudly hosted its President's Recognition Banquet, honoring Wall of Honor recipients and The Impact of Philanthropy Awardees during the 2025 Homecoming festivities.

The Alumni Wall of Honor welcomed four outstanding alumni: Kym Gable, Mickey Marotti, Joe Nolan and Denise Penz. This honor is given to alumni who have excelled in their careers or made significant contributions through service.

The WLU Foundation presented the Impact of Philanthropy Awards to a select group of donors who contributed generously—\$25,000 or more during fiscal year 2025—to advance priority projects for WLU. The 2025 awardees included Rich '69 and Terry Achtzehn, Expand Energy, Peggie Dalrymple Mueller, Joan & Fred Stamp, and Flip West & The West Family.

Rich and Terry Achtzehn made a substantial gift to the Bobby Douglas Wrestling Complex Campaign. Expand Energy was recognized for their support of the Campus Woods Trails project.

Peggie Dalrymple Mueller provided funding to permanently endow two scholarships in the College of Education in memory of her mother Doris Waddell Dalrymple and her brother Robert "Bob" Theodore Dalrymple. A gift from Joan & Fred Stamp established the "Joan Stifel Corson Aviation Scholarship" in memory of Joan's late mother who was among the first women aviators in the northern panhandle of West Virginia. A generous gift of \$1.7 million from Flip West and the West family enabled the creation of the Gary E. West Aviation Center on campus and the permanent endowment of the Gary E. West Aviation Scholarship

## TRAILBLAZING SUPPORT FOR CAMPUS WOODS TRAILS



West Liberty University's vision to transform the 169 acres of the Campus Woods into a vibrant trail system took a major step forward thanks to a \$25,000 grant from Expand Energy. This lead gift is fueling enhancements that will make the trails safer, more accessible, and more enjoyable for students, faculty, and the surrounding community. From improving pathways to adding key infrastructure, Expand Energy's investment ensures that the trail system becomes a lasting resource for recreation, research, and wellness.

The project has also benefited from additional partnerships that amplify its impact. A Volunteer West Virginia September 11th Day of Service Grant supported a large-scale volunteer event during new student orientation, where more than 50 participants—including students, faculty, and community members—worked together to install gravel, build and place benches and picnic tables, blaze trails and clear debris and invasive species. These efforts reflect the University's commitment to service and sustainability.

Further strengthening the initiative, the WLU Foundation was awarded a grant of professional grade tools from the Warwood Tool Company which equipped volunteers and maintenance teams with the resources needed for ongoing upkeep. This collaboration ensures that the trail system will remain well-maintained and accessible for years to come.

Creativity has also played a role in shaping the project's identity. Under the guidance of Professor Moonjung Kang (Visual Communication Design), WLU student Bre Boogaart developed branding and signage for the trail system, giving it a distinctive look that celebrates the natural beauty of the Campus Woods. Her designs were featured on shirts and hats that were given to volunteers on our day of service.

Together, these contributions demonstrate how strategic partnerships and student innovation can create a lasting legacy for health, learning, and community engagement.

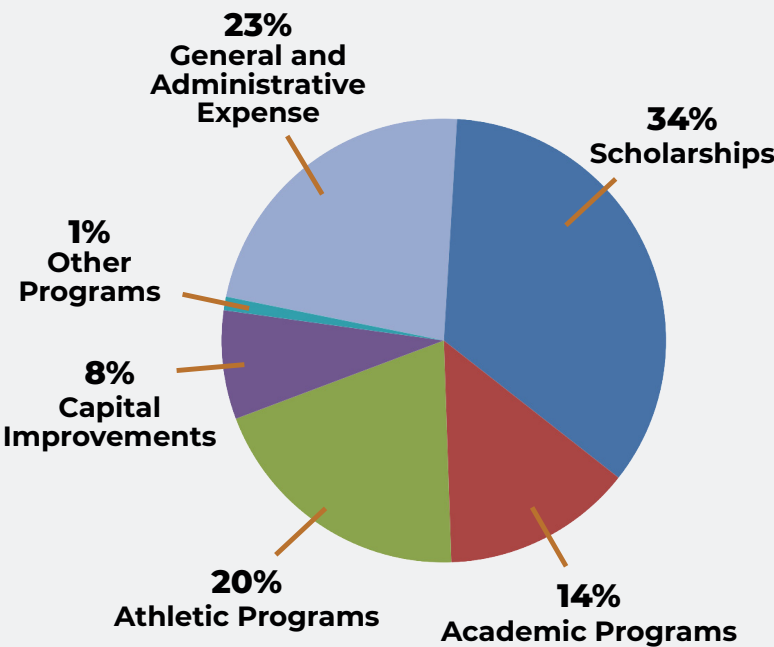

# DAY OF GIVING SUCCESS



## NINTH ANNUAL DAY OF GIVING SURPASSES OVER \$300,000 RAISED FOR THE FIRST TIME

The West Liberty University Foundation held its ninth annual Topper Day of Giving on March 26, 2025, and for the first time in the event's history, the total amount raised surpassed \$300,000!

This is also the fourth consecutive year the Day of Giving exceeded the \$200,000 mark. Topper Day of Giving has seen significant boosts in participation since its inception in 2017 and has raised over one million dollars to support university programs, student scholarships, and the WLUF Annual Fund.

This year, the 24-hour giving day saw a total of 1,181 gifts come in from 1,066 different donors. For the fourth year in a row, the Wrestling program had the highest donor participation

with 190 donors. Biology, which was a new micro campaign last year, came in second for the second straight year with 149 donors, followed by the Theatre Department (137 donors).

In total dollars raised, the top three campaigns were Biology (\$27,548),

Theatre (\$22,590), and the PA Program (\$13,060).

# JOSEPH BROTHERS ESTABLISH ENDOWED SCHOLARSHIP TO SUPPORT FEMALE AVIATION STUDENTS

A highlight of the Foundation's fiscal year was the establishment of the Virginia Lee Joseph Scholarship, a permanently endowed fund created by brothers Dr. Daniel and Brian Joseph in memory of their mother, Virginia Lee Joseph, a pioneering aviator who earned her pilot's license in the 1950s.

The scholarship will support female students pursuing careers in aviation, continuing Virginia's legacy and passion for flight. As one of the few women to earn a pilot's license during a time when aviation was overwhelmingly male-dominated, Virginia Joseph exemplified courage, determination, and a trailblazing spirit—qualities her sons hope to inspire in future generations of women aviators.

"We wanted to honor our mother's remarkable life and her love of flying by

helping other women take to the skies," said Daniel Joseph. "This scholarship is a tribute to her legacy and a way to open doors for young women who share her dream."

Brian Joseph added, "Our mother believed in breaking barriers. Through this scholarship, we hope to empower women to pursue aviation with confidence and purpose."

The Joseph brothers are both WLU Alumni and members of the Alumni Wall of Honor. Daniel, who has practiced orthodontia in Wheeling for 45 years, has served as president of the Wheeling District Dental Society and the West Virginia Orthodontic Association and as president and treasurer of the West Virginia Dental Association. He has served on the West Liberty University

Board of Governors and is a member and past Chairman of the WLU Foundation Board of Directors.

Brian is President, CEO and founder of Touchstone Research Laboratory which has created hundreds of inventions with extraordinary success in materials development, new products, and aerospace testing. Brian is a member and past president of the J.B. Chambers Foundation and served as chairman of the West Liberty University Board of Governors.

## EXPLANATION OF FOUNDATION FUNDS

Listed here are the various funds held by the West Liberty University Foundation, Inc.

### RESTRICTED GIFTS

Donations made to the West Liberty University Foundation, Inc. with a specific purpose stated by the donor.

### UNRESTRICTED GIFTS

Donations made to the West Liberty University Foundation, Inc. support the WLU Foundation Scholarship Program and areas of greatest need, which are identified by the WLU Foundation Need Request Proposal Process.

### TYPES OF FUNDS

#### NAMED ENDOWED FUND

A named endowed fund can be established to provide scholarships, support a professorship or chair in a particular academic area, or support another purpose based on the interest of the donor. An endowment requires that the principal remain intact in perpetuity, or for a defined period of time, or until sufficient assets have been accumulated to achieve a designated purpose. West Liberty University Foundation, Inc. requires a minimum initial gift of \$25,000 to establish an endowed fund. Named endowed funds are listed on an annual basis in certain WLU Foundation publications.

#### TEMPORARILY ENDOWED FUND

A temporarily endowed fund with a balance of less than \$25,000 may be established with the understanding that the donor(s) or governing body intends to fund at minimum \$25,000 level and that no income generated by the gift principal will be distributed until the \$25,000 minimum principal balance has been achieved. If not fully funded within five years, the temporarily endowed fund will be considered part of the Foundation's general endowment.

#### NON-ENDOWED FUND

A non-endowed fund is a fund held by the foundation designated for a specific use over a shortened period of time, e.g.; Organization accounts; Study Abroad; Capital Projects, etc.
